## Club Records

---

*Policy and Procedures Manual - 405*

*The Pioneer Archers are committed to recognising the achievements of our athletes by establishing Club records and awarding certificates acknowledging the athletes prowess with the bow.*

## Club Records Policy

1. A performance recorded by an affiliate athlete to Pioneer Archers Inc. ("the Association") for a score (including a perfect score) that betters a previously recorded score shall be recognised as a Club record, provided that it was shot in accordance with the Association's Rules.
2. A score shot by an affiliate athlete of the Association while competing in an Archery Australia (AA) or Archery Western Australia (AWA) approved tournament, and competing as a representative of the State or Club, may also be recognised as a Club Record;
  - 2.1. provided that adequate evidence of the score and the bona fides of the event are provided to the Association's Recorder.
3. Except as provided for in clause 2, a record may be established in an event conducted by a recognised body, provided that:
  - 3.1. The recognised body is affiliated to Archery Australia, and/or
  - 3.2. There were at least three affiliated archers participating in the scoring and witnessing process.
4. Except as provided for in clause 2, the score sheet containing the complete score or performance of the athlete creating the Record, certified by the athlete, a scorer and/or a witness, must be handed to the Association's Recorder at the conclusion of the event or within 14 days if the event is not held at the Association's normal shooting venue.
  - 4.1. All information required on the score sheet must be completed;
  - 4.2. Questions relating to omissions and errors may be raised with the Association's Recorder for a period of up to one month from the completion of the event;
  - 4.3. Disputes arising from claims must be forwarded to the Association's Committee of Management for determination, within a period of two months from the completion of the event.
  - 4.4. After the period specified in (4.3) has expired there can be no further discussion.
5. Except for the 36 arrow records listed in clause 6, a Club Record may only be claimed for the round actually shot. Records for other rounds which could be derived from that round cannot be claimed.
6. Distance records can be claimed of any Division when the round being shoot includes 6 ends at any of the following distances on the nominated size target face;
  - 6.1. 122cm target face - 90m, 70m, 60m, 55m, 50m, 45m, 40m, 35m, 30m and 20m;
  - 6.2. 80cm target face – 50m, 40m, 35m, 30m and 25m.
7. For FITA Indoor Rounds all Compound athletes shall shoot the inner 10, with the exception of Barebow Compound athletes.

### 8. Categories

Club Records shall be in two categories;

#### 8.1. Club Overall Records:

A Club Overall Record shall be one which is established at an event as allowed for under clause 3 and is conducted in accordance with these rules.

8.1.1. There will be a record claimable for each gender group in the following divisions;

- 8.1.1.1. Compound
- 8.1.1.2. Recurve
- 8.1.1.3. Longbow
- 8.1.1.4. Compound Barebow
- 8.1.1.5. Recurve Barebow

8.1.2. Within each division the following Classes of athlete will be recognised;

- 8.1.2.1. Cub
- 8.1.2.2. Intermediate
- 8.1.2.3. Cadet
- 8.1.2.4. 20 & Under
- 8.1.2.5. Open
- 8.1.2.6. Master
- 8.1.2.7. Veteran
- 8.1.2.8. Veteran Plus

the age requirements for each Class will be consistent with Archery Australia rules.

## 8.2. **Classification Club Records;**

If a gender/division/class group contains more than three (3) Association members, a Club Classification record can be claimed in a manner consistent with these rules.

- 8.2.1. A record achieved within a Classification can also be claimed as a Club Overall Record.
- 8.2.2. A Club Record as provided for under clause 2, can only be claimed for the division/class in which the athlete entered the event.
- 8.2.3. The following classification records groups will be recognised;
  - 8.2.3.1. Gold
  - 8.2.3.2. Red
  - 8.2.3.3. Blue
  - 8.2.3.4. Black
  - 8.2.3.5. White

## 9. **Club Rounds**

- 9.1. The Committee of Management may introduce “Club Only” rounds, the records for these rounds will only be open to novice archers.
- 9.2. The naming convention for the rounds will be; PA [*Distance in Meters*] – [*Maximum Score*]

## 10. **Recognition of Records**

- 10.1. Every Club record claim shall be approved by the Association’s Recorder.
- 10.2. The Association’s Recorder shall examine every claim for a record and may require further evidence.
- 10.3. The athlete concerned shall be advised of the granting of a Club Record by the receipt of a Record Card, that includes the athlete’s name, the round or distance shot, the score achieved, the division and the date that the record was achieved.
- 10.4. The Association will make available a list of the most up to date records held by the Association, in an electronic format. They will be displayed in a manner and format that is the most practicable and suitable for the technologies of the day.
